













### Financial Performance Q2 FY'2024 (Consolidated)








### Financial Performance H1 FY'2024 (Consolidated)









### Financial Performance H1 FY'2024 (Consolidated)






### Financial Position H1 FY'2024 (Consolidated)




### Financial Ratio H1 FY'2024 (Consolidated)






### NET PROFIT Q2 2017-2024

**Unit: Million Baht** 




### ROA (%) Q2 2017-2024






### ROE (%) Q2 2017-2024




### Cash and cash equivalents Q2 2017-2024
